- **Fee:** \$15. (This covers the pool fee and all food and beverages.)
- **Permission Slip Due:** Friday, March 4.
- **Paypal:** You can use Paypal to pay for Troop 61 Events. Login to Paypal and send the \$15 Fee to treasurer@troop61.com with a note "*Name of Scout – Overnighter at YMCA.*" If you use a Bank Account for the funds, there is no fee. If you use a Credit Card there is a \$0.33 fee (fee kept by Paypal).
- **Special Daylight Saving Time Note:** Daylight Savings Time begins on March 12th at 2:00am -- right in the middle of the All Nighter!! At 2:00am we will "spring forward" and set our clocks to 3am. We will drop scouts off at 6:00am. (Which will feel like 5:00am to you!)
