Alpine ski equipment: For ski rentals, I understand the boot/binding system which I have rented is designed to reduce the risk of certain injuries to the lower leg. It will not release at all times or under all circumstances where a release may prevent injury, nor is it possible to predict every situation in which it will release. I understand the boot/binding system will not reduce the risk of injury to my knees or other parts of my body. I further understand the boot/binding system does not have a backward release capability and will not release or protect any part of my body in the event of a backward fall. I therefore understand the boot/binding system I have rented CANNOT GUARANTEE MY SAFETY.

Snowboard equipment: I understand and agree that these systems normally will **NOT RELEASE** in falls and accidents, and that these features are inherent risks of using non-release bindings.

Helmets: I understand and agree that no headgear can protect against all foreseeable impacts, that skiing and snowboarding can expose the user to forces that exceed the limits of protection offered by this helmet, that helmets do not guard against injury to the neck, spine, face or any other part of the body, and that these features are inherent risks of using this equipment. Helmets must be properly fitted to each user, and I agree that this helmet has been properly fitted by the provider. I warrant that the helmet is comfortably snug and that when I fasten the chin strap and shake my head there is no significant movement of the helmet. I agree if the helmet is damaged or involved in any kind of accident, I will **stop using the helmet** immediately, return it to the shop and **report any accident or damage**, because any damage to the helmet, even if not visible, might compromise its ability to provide protection.

Renter accepts full responsibility for the return of Sunburst's rental equipment. In the event of loss or failure to return Sunburst's rental equipment, user will be required to pay Sunburst the sum of \$250.00 (replacement value of rental package).
