**Warming House:** Available for both tubers and skiers.

**Snacks:** The troop provides snacks and beverages for tubers only. Skiers should bring optional spending money for the grill and snack shop at the base of the ski hill.

**Skill Levels:** Experienced skiers and boarder do not have to take lessons, and are free to explore the slopes at Sunburst with a buddy. Beginners are strongly encouraged to take the one hour lesson from the professionals. Skill at skiing does not translate to snowboarding.

**Uniform:** Not required.

**Ski Gear:** Warm leather palm gloves or equivalent. Tow ropes are not kind to knit gloves and mittens
